## Medical Cannabis Voter Guide South Carolina House of Representatives June 9, 2020 Primary Election

See below for a voter guide outlining where each primary candidate for the South Carolina House of Representatives stands on medical cannabis.

Candidates in **green** have indicated their support for medical cannabis in response to the South Carolina Compassionate Care Alliance's (SCCCA) candidate survey or by cosponsoring a medical cannabis bill (if they are an incumbent). Candidates in **red** expressed opposition to medical cannabis, and candidates in **orange** are not known to have taken a public stance or replied that they are undecided.

You can vote in either party's primary on June 9: South Carolina does not have registration by party. Only the Democrat and Republican parties have competitive primaries on June 9.

However, *prescribing* marijuana would violate federal law as does dispensing it. Pharmacies and doctors are unlikely to break federal laws. Effective medical cannabis laws rely on "recommendations" or "certifications" and dispensing from dispensaries.
